2020 AAKC Education Scholarship Application

The Apartment Association of Kansas City announces its Education Scholarship Fund to provide a qualifying candidate or candidates the opportunity to receive funds necessary in obtaining a National Apartment Association Education Institute (NAAEI) designation such as NALP or CAM. All applicants must hold a valid High School Diploma or equivalent and meet the following minimum multifamily housing employment requirement.

NALP – (National Apartment Leasing Professional) One year’s experience as an Apartment Leasing Professional

CAM – (Certified Apartment Manager) One year’s experience as a Property Manager/Assistant Manager in the Apartment Industry.

Careful consideration is given prior to awarding a scholarship with special emphasis placed on an individual’s commitment to the industry, general industry knowledge, ethics, and overall character. The employee’s company must be in good standing and a member of the AAKC in the year for which you are applying.

Scholarship applications must be completed and returned no later than February 7th for NALP Spring class and February 28th, 2020 for CAM Scholarship. The individuals who are selected for these scholarships will be notified by phone two weeks prior to class starting.
